#### COMMENTS:

Noble has performed two blowdowns on the Monfort Gilcrest K08-10. The first blowdown, performed on 12/11/2019, started at 35 psi and collected 0 mcf of gas and 18 gallons of fluid. The second blowdown, performed 1/20/2020, started at 34 psi and collected 0 mcf gas and 21 gallons of fluid. A Form 17 was completed on 1/24/2020, beginning at 29 psi (doc# 402303040). A gas sample was not collected prior to blowdown, but a production gas sample was collected on 1/31/2020 and will be submitted. Water to surface is present in the bradenhead and there is not enough gas to collect a bradenhead gas sample.

We are electing to P&A rather than continue with the monitor and blow down program. This well will be P&A'd before 8/1/2020.
