Well shut-in for horizontal safety prep. RBP set at 7110' with sand on top. Pressure tested to 500 psi for 15 minutes on 8/29/18. Good Test. An additional RBP was set at 7025' with sand on top. Pressure information is included with the Operations Summary Report submitted with the Form 5A on 9/21/2018. TA Status is provided by a downhole plug and surface isolation is provided by closed master valve. This well has been evaluated and is planned for plug and abandonment in Q1, 2021
