 Field Inspector Actions:  
 On 2-23-2020, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Adam Makos 4070 Kestrel Drive Broomfield CO stated the issues were occurring outside of complainants home.  
 On 2-24-2020, I attempted to make contact with the complainant who indicated that on 2-23-2020 experienced an incredibly loud noise. A constant high pitched droning sound. I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not observe any unusual noise in or around location. At time of inspection there were three coil tubing units and associated equipment on site performing drill out phase. I requested third party sound data and after reviewing data it appeared the Livingston location at time of the complaints was within COGCC sound rules. Sound data will be attached to complaint inspection document.  
 On 2-25-20, I spoke with Extraction Oil and gas Representative Nathan Bennett he stated since my inspection on 2-24-20 Extraction has removed one coil tubing unit. The two remaining units on site will both run during the day. At approx... 10:00 PM one unit will shut down until 7:00 AM next day so only one coil tubing unit will be performing nighttime operations.  
 Weather conditions: Cloud and location muddy

 No violation of COGCC rules were observed at the time of the inspection.
