Noble Energy respectfully requests continued TA status. The well is closed to the atmosphere via a CIBP bridge plug set at 7536' on 2/27/2018. The well is closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the J Sand formation. This well was TA'd for an off-set frac, Noble's BISON RIDGE Y22-771 Pad. Noble will plug and abandon or return the well to production within the next 5 years. Noble is currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Form 5A to change the status to TA was submitted on doc # 401712801.
