Noble Energy respectfully requests continued TA status. The well is closed to the atmosphere via a RBP set at 6606' on 1/17/2016. The well is closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the Niobrara-Codell formation. This well was TA'd for an off-set frac, Bayswater's Carlson Pad. This well is part of the AOC (Order No 1V-668) and the bradenhead pressure will be monitored and action taken as necessary as outlined in the AOC. Noble is currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Form 5A to change the status to TA was submitted on doc # 401042662. Successful MIT was performed on 6/30/2018 and submitted on doc # 401694178. This well is tagged with a yellow tag.
