General Comment:**COGCC Inspection Report 689803706 Summary**

On Thursday 02/27/2020 at approximately 10:45, I, Inspector Emily Waldron, conducted a field inspection at North Shore Exploration and Production LLC Smith #1, at 05-081-06843 in Moffat County Colorado.

While there, I observed Production and performed a follow up to inspection report 689803307 submitted 11/14/2019.

During both inspections the following possible compliance issues were observed:

Free product in tank berm at base of crude tanks. Tanks appear to have overflowed, soil in

berm appears saturated with hydrocarbons in addition to free fluid present. See photos 1-8. Control and contain spills/releases and clean up per Rule 906.a by 11/12/2019.

On 11/12/2019 I spoke with Marina at North Shore and she informed me that the product was being cleaned up and was estimated at 0.7 BBL volume release within containment.

No evidence of any clean-up was observed during today's follow up inspection. I called Marina back to inform her of continued existence of product on location.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
