Enhanced fluid recovery (EFR) and air sparge (AS) activities were conducted between the second quarter 2014 and second quarter 2018. Active and passive light non-aqueous phase liquid (LNAPL) recovery has been conducted since the first quarter 2013. Operation of a solar soil vapor extraction (SVE) system has been conducted since first quarter 2016. LNAPL recovery and operation of the SVE system will continue through the second quarter 2020.

PDC will continue to sample the ten (10) monitoring wells (BH01R, BH02 – BH04, BH05R, and BH07 – BH11) and one remediation well (SVE Well) on a quarterly basis to assess the dissolved phase petroleum hydrocarbon impacts in groundwater using USEPA Method 8260. Groundwater sampling will continue until four consecutive quarters of groundwater monitoring data indicate that BTEX concentrations are in compliance with the COGCC Table 910-1 groundwater standards.
