KPK is requesting to remove the 100 bbl produced water storage vessel, which meets the definition of a partially buried vessel, from the McElwain 13-17 Tank Battery. The well associated to the tank battery is being P&A'd and the facility is planned to be removed. The partially buried storage vessel will be permanently closed per Rule 905.b.
