OPERATOR COMMENTS AND SUBMITTAL

Comments

The distance to the completed portion of the nearest well on the "Spacing & Formations" tab was measured to the proposed Fetcher 7E-20-12N, Extraction Oil & Gas. The distance to the completed portion of the nearest well belonging to another operator on the "Drilling & Waste Plans" tab was measured to Nickel Creek's proposed Moore 8X-HNB-10-07-67. Both distances were measured in 2D via COGCC GIS Mapping.

The proposed wellbore will be drilled less than 150' from the proposed Fetcher 7E-20-12N well when measured in 2D via COGCC mapping. Extraction is the operator of both well proposals, so no Stimulation Setback Consent is required.

Please find Surface Use Agreement is attached to the Scout Card.

The surface owner has waived Rule 318A.a. Please see signed surface location exception waiver and request letter attached.

Notice shall be given to all offset operators prior to drilling.
2	Drilling/Completion Operations	Operator acknowledges and will comply with COGCC policy for Bradenhead Monitoring during Hydraulic Fracturing treatments in the Greater Wattenberg Area dated May 29, 2012.
3	Drilling/Completion Operations	One of the first wells drilled on the pad will be logged with open-hole resistivity log and gamma-ray log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall state "Alternative Logging Program - No open-hole logs were run" and shall clearly identify the type of log and the well (by API#) in which open-hole logs were run.
