**General Comment:**

This is an Abandoned Location Inspection, for Four Wells, listed in Inspected Facilities, above. APDs were first Approved in 2006-2008 for Windsor Energy; Permits Abandoned in 2011, 2013 & 2016 by Ursa. It does not appear that these AL Wells were drilled on Location with One Producing Well; therefore, these are Well Releases on an Active Location.

These Wells were previously passed for Final Reclamation; however they were inadvertently Checked in Field Inspection in 2018 giving them an Active Priority Status. This Inspection clears the mistaken Active Priority Status.
