1. MIRU pulling unit. Release packer and pull 2 3/8" tubing.

2. RU wireline company.

3. TIH with CIBP. Set BP at 6977'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Codell perms @ 7027')

4. TIH with CIBP. Set BP at 6677'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Niobrara @ 6727')

5. Run CBL from 6600' to surface.

6. TIH with CIBP. Set BP at 4090'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Sussex @ 4140')

7. TIH with tubing to 3665'. RU cementing company. Mix and pump 25 sxs 15.8#/gal CI G cement down tubing. (Casing patch plug from 3665'-3335')

8. Pick up tubing to 1480'. Mix and pump 112 sxs 15.8#/gal CI G cement down tubing. (Pierre coverage from 1480'-surface) Cement should circulate to surface.

9. Cut surface casing 6' below ground level and weld on cap.
