Corrective Action:

Comply with the reclamation rules to remove (regardless of ownership) all debris, abandoned gathering line risers, and flowline risers, and equipment within three months of plugging (8/7/2019) the associated facility. All work should have been conducted by 11/7/2019.

Corrective action date is being backdated to when all equipment associated with oil and gas operations should have been removed.
