

Dear Mr. & Mrs. Tempel:

This letter is being sent to you to inform you that Mull Drilling Company, Inc. will be drilling a well at the above-referenced location in the near future on the lands, which you are the surface owner. We will be contacting you in the near future so that we may meet with you or your tenant, prior to commencing any physical operations on your property. We will settle surface damages with you as the surface owner prior to entry on your property. When we meet we will also discuss the best route of ingress and egress on the property with you. At this time we will also discuss with you, if we establish production, where we will locate the production facilities.

We anticipate spudding drilling of the well in Section 32 approximately December 1, 1999 and a representative of our company will contact you prior to entry upon your property to stake the location or move any heavy equipment onto location.

We also enclose the following information for your review:

- A copy of the brochure prepared by the State of Colorado Oil and Gas Conservation Commission outlining the Consultation and Reclamation rules.
- A waiver of Notice Letter of Intent to Drill, which we would request that you execute and return to Mull Drilling Company, Inc. in the envelope provided.

- A copy of the Rules and Regulations of the State of Colorado concerning the notice period and consultation provisions required by the State of Colorado.


