Well was originally shut-in for Horizontal Safety Prep. CIBP SET AT 7870' WITH 2SXS CEMENT AND CIBP SET AT 7120' WITH 2 SXS CEMENT. A mechanical integrity test was performed to ensure integrity of the casing 02/25/19. The well has been evaluated and is on our schedule to plug and abandon. TA status provided via a down-hole plug and surface isolation provided via closed master valve.
