INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried fiberglass produced water vessel (PWV) was removed from the Beierle 5-26 location on January 29, 2020. While decommissioning additional equipment, a second crushed concrete PWV was discovered buried south of the fiberglass vessel and also removed. Groundwater and impacted soil were not encountered in either PWV excavation. A liner was not present beneath either PWV at this site. Both PWVs at this facility have been permanently removed. The general site layout, soil sample locations, and PWV excavation dimensions are depicted on the Facility Layout & Sample Locations Map provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On January 29, 2020, soil samples were collected from the sidewalls and base of both the north and south excavations. The soil samples were field-screened for volatile organic compounds using a photoionization detector (PID). Soil samples B01N@4', N01N@3', E01N@3', S01N@3', and W01N@3' from the north excavation and soil samples B01S@6', N01S@4', E01S@4', S01S@4', and W01S@4' from the south excavation were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. The base soil samples were also analyzed for pH, specific conductance (EC), and sodium adsorption ratio (SAR). Laboratory analytical results for all soil samples indicate that BTEX, TPH, naphthalene, pH, EC, and SAR concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels. The soil sample analytical results are summarized in Table 1, and the laboratory analytical report is attached.

Laboratory results indicate that all soil samples were in full compliance with COGCC Table 910-1 allowable levels; therefore, no soils were removed. The excavation areas were backfilled and contoured to match pre-existing site conditions.

Laboratory results indicate that all soil sample concentrations were in compliance with COGCC allowable levels. Groundwater was not encountered in either PWV excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. This supplemental Form 27 has been prepared to request a No Further Action (NFA) determination for this site.
