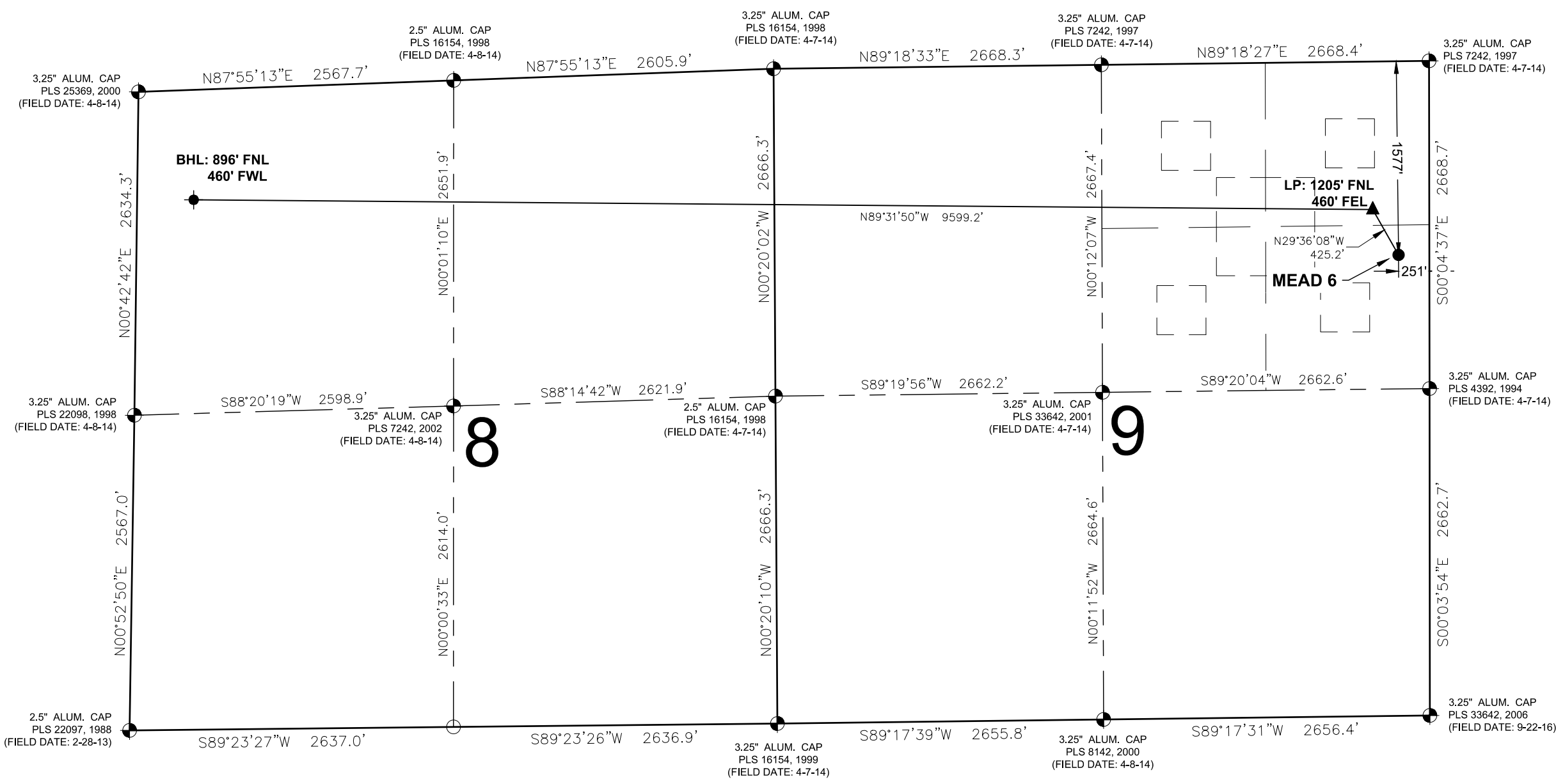

WELL LOCATION EXHIBIT

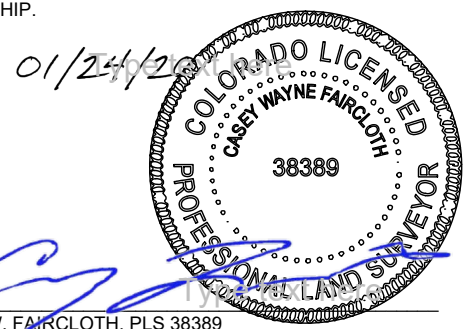


- NOTES:

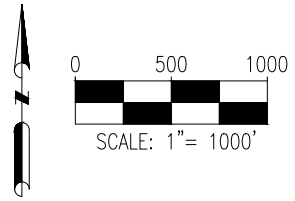
