Operator has failed to perform any of the previous corrective actions to conduct final reclamation activities and control erosion. Refer to the attached inspection photos.

Operator has failed to conduct the following: (1) well location has not been contoured to match the surrounding landscape; rill erosion evident along the eastern cut slope. At a minimum, the Operator shall reduce the cut and fill slopes to prevent further erosion. The cut slope does not have any vegetation establishment. (2) The battery location is not reflective of reference area vegetative conditions and there is gully erosion which continues west, off location.
