INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Five discreet confirmation soil samples will be collected (4 wall and 1 base) from the produced water tank excavation. The base and wall samples from the downgradient wall or the sample with the highest PID reading will be analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, gasoline range organics (GRO), and diesel range organics (DRO). In addition, the base sample will be analyzed for pH, Electrical Conductivity (EC), and Sodium Absorption Ratio (SAR). See the attached Figure 2.
