INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried produced water vessel (PWV) was removed from the HSR-Van Schaack 13-33 location on March 3, 2020. Groundwater and impacted soil were not encountered in the PWV excavation. A liner was not present beneath the PWV at this site. The PWV at this facility has been permanently removed. Soil samples from the excavation were submitted for laboratory analysis, to determine if a release occurred. The general site layout, soil sample locations, and PWV excavation dimensions are depicted on the Facility Layout & Sample Locations Map provided as Figure 1. The soil sample analytical results are summarized in Table 1, and the laboratory analytical report is attached.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

On March 3, 2020, following removal of the PWV, soil samples were collected from the sidewalls and base of the excavation. The soil samples were field-screened for volatile organic compounds using a photoionization detector (PID). Soil samples were submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), total petroleum hydrocarbons (TPH), and naphthalene. The base sample was also analyzed for pH and specific conductance (EC). Due to the lab receiving insufficient volume of analyzable sample media for the base sample, the sidewall sample with the highest PID value (S01@3) was analyzed for sodium adsorption ratio (SAR). Laboratory analytical results for all soil samples indicate that BTEX, TPH, naphthalene, EC, and SAR concentrations and levels were in full compliance with COGCC Table 910-1 allowable levels. B01@5 exceeded allowable pH levels; however, this was collected below the root zone and will have no affect on revegetation during reclamation.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Laboratory results indicate that all soil samples were in full compliance with COGCC Table 910-1 allowable levels, with the exception of a slight pH exceedance at B01 @5'. However, this was collected below the root zone and will have no affect on revegetation during reclamation; therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory results indicate that all soil sample concentrations were in compliance with COGCC allowable levels for BTEX and TPH. Groundwater was not encountered in the PWV excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. This supplemental Form 27 has been prepared to request a No Further Action (NFA) determination for this site.
