Comment Well pad cut and fill slopes are hydromulched and seeded since 2018 reclamation inspection. Revegetation appears to be progressing in portions of the re-seed areas, although remains sparse in other portions. Revegetation and erosion need to continue to be monitored and managed within the project area until cut and fill slopes are properly stabilized. Noxious weeds were not observed, although it is early in the growing season and they may not be observable at this time. This also needs to be monitored.
