COMMENTS:

Bonanza Creek respectfully requests continued TA status. The Antelope 19-I was plugged back with CIBP @ 6346' with 2 sacks of cement on 11/08/2018. Form 5A to report TA status of Nio/Codell was submitted 12/31/2018 (Doc # 401881031). The well was SI and plugged back due to offset HZ frac of Bonanza Creek's Antelope T-19 Pad. The well is closed to the atmosphere via valve locked out and tagged out at the master valve, and the a "Temporary SI for HZ prep" sign is attached to the master valve. Well pressure tested at time of CIBP setting; pressure tested to 1500 psi, held pressure for 10 minutes, test was good. This well will remain TA'd until and after frac completion pad, previously mentioned, is completed. Bonanza Creek has this well on their Projected P&A budget planning schedule for the next years to come, as budgets allow. If not PA'd by that time, an annual TA sundry notice will be submitted in 1st Quarter 2021 to update the COGCC on the plans of this well.
