Comment: Soil pile referred to in Reclamation section is not stabilized and has no containing BMPs. Any loose Piles of Soil are potential Pollution sources. Erosion is occurring in several areas of Location; resulting in migration of sediment onto and off of site. Repair of existing controls and additional BMPs are needed. One rocked drain is well maintained but does not appear to be in effective position. Refer to Photo Log attached.

Corrective Action: Install sufficient/effective/structured BMPs in accordance with, and monitoring per Good Engineering Practices per Rule 1002.f.
