Comment Revegetation is progressing within the majority of the interim reclamation area, although remains sparse along cut-slopes at well pad entrance and portions of the southern edge of the working area (see corrective action under "Stormwater" below). Weeds were not observed at this time, although it is early in the growing season and weeds may not be observable. Continued monitoring and treatment (as needed) needs to be conducted.
