#### COMMENTS:

Noble has performed four blowdowns on the Alexander F34-33. The first blowdown, performed on 11/20/2019, started at 38 psi and collected 0 mcf of gas and 1gallon of fluid. The second blowdown, performed 12/26/2019, started at 107 psi and collected 8 mcf of gas and 54 gallons of fluid. The third blowdown, performed 1/13/2020, started at 96 psi and collected 4.5 mcf of gas and 20 gallons of fluid. The fourth blowdown, performed 1/20/2020, started at 72 psi and collected 2.1 mcf and 0 gallons of fluid.

A Form 17 was completed on 2/18/2020, beginning at 114 psi. A gas and oil sample was collected prior to the first blowdown and has been submitted.

We are electing to P&A rather than continue with the monitor and blow down program. This well will be P&A'd before 7/1/2020
