During this inspection the following Corrective Actions from previous inspections are delinquent:</p> <p>603.f Housekeeping: Dead weeds around sep, tnk btry, and wh. Trash and unused oil containers inside pumping unit house, buckets and yellow lid around location, stained soil at various spots around location.</p> <p>210.b: No capacity sign on oil tank. Thief hatch appears to be open to atmosphere. This is being referred to Enforcement; therefore, there is no corrective action date.
