- 1) 679705826 dated 10-28-2019.
- 2) 679706487 dated 12-9-2019.

The following compliance issues were resolved:

- 1) No sign present at location.
- 2) Unmarked deadman in SE corner.

Additional compliance issues:

- 1) Sign has incorrect operator emergency phone number. Photo 7. Complete by 5-6-2020.
- 2) Well head leaking hydrocarbons & fluid on ground. Photos 2 to 5. Complete by 4-8-2020.
- 3) Unmarked deadman in NW corner. Photo 8. Complete by 5-6-2020.
- 3) Lease road has culvert exposed. Photo 9. Complete by 5-6-2020.

Operator was contacted at 800-209-9762 at 16:08 in regards to the leak once the inspector had cell service.

This well is located in a pasture and 105' from the White River.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
