Comments "Noble respectfully submits this application for a permit to drill, which is a part of a six well pad producing to pad A20-15. Nearest well in the same formation is the Rampart A32-730, the distance was calculated using 2D data. The nearest well belonging to another operator is Miller 33-29, SI, 05-123-19479, operated by PDC Energy - 69175. Distance was calculated in 3D using anti-collision report. 317.S consent is required. The Exception Location and Twinning Waiver language is included in the attached SUA, (Page 4, Section 6). Noble Energy shall isolate both the Fox Hills and Upper Pierre Aquifers with surface casing from hydrocarbon bearing zones and exposures to oil based drilling fluid. Noble Energy also agrees to not expose the Upper Pierre Aquifer to oil based mud."
