While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. Appears to be stained soil underneath mast valve. CONDUCT MAINTENANCE ON EQUIPMENT, CLEANUP STAINED MATERIAL AND REVIEW SELF INSPECTION PROCESSES PER RULE 1002.F.(2).D. (Corrective Action Date: April 20, 2020) See attached photo #3.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
