Based on initial site assessment activities, sidewall soil sample VP-SS-02 at 3' below ground surface (bgs) contained SAR and pH concentrations exceeding applicable table 910-1 regulatory limits. Additional inorganic assessment sampling will be completed to determine the extent of inorganic impacts. Inorganic impacts within the root zone (<3' bgs) will be excavated and either used as backfill beneath the root zone at the other remedial excavation near the former separator (REM #15371), which has a total depth of approximately 5' bgs, or disposed of off-site.
