8.5" drilling assembly became stuck @ ~4520' (Sussex Fm) while TOOH from TD  
TD - 17,471' MD  
9.625" 36ppf surface casing shoe @ 1934'  
8.5" bit, rotary steerable BHA, motor, (3) jts 5" HWDP, (1) severed joint of 5" DP – top of fish 4295', bottom of fish 4528'  
2x 600' (42bbls each) cement plugs from ~4200'-3000'MD  
17ppg (0.98cf/sk) Halliburton GraniteCem  
ST KOP – ~3319'  
Same objective formation (Niobrara) will be targeted in the sidetrack  
TPZ and BHL for sidetrack will be 76ft east and 45ft east, respectively, of the originally permitted wellbore.
