Operator Comment: The oily waste was removed from the PC engine skid and the liquid ring compressor skid immediately. The impacted soil around the liquid ring was removed from location. The maintenance to the liquid ring compressor was completed 04/07/20. The lease road was regraded to eliminate the surface erosion and establish sheet flow. The bar ditch was dominated to direct run off to the culvert inlets. The sediment was removed from the culvert inlet. The erosion rill on the fill slope was back filled and seeded by hand broadcast with an approved CPW seed mix.
