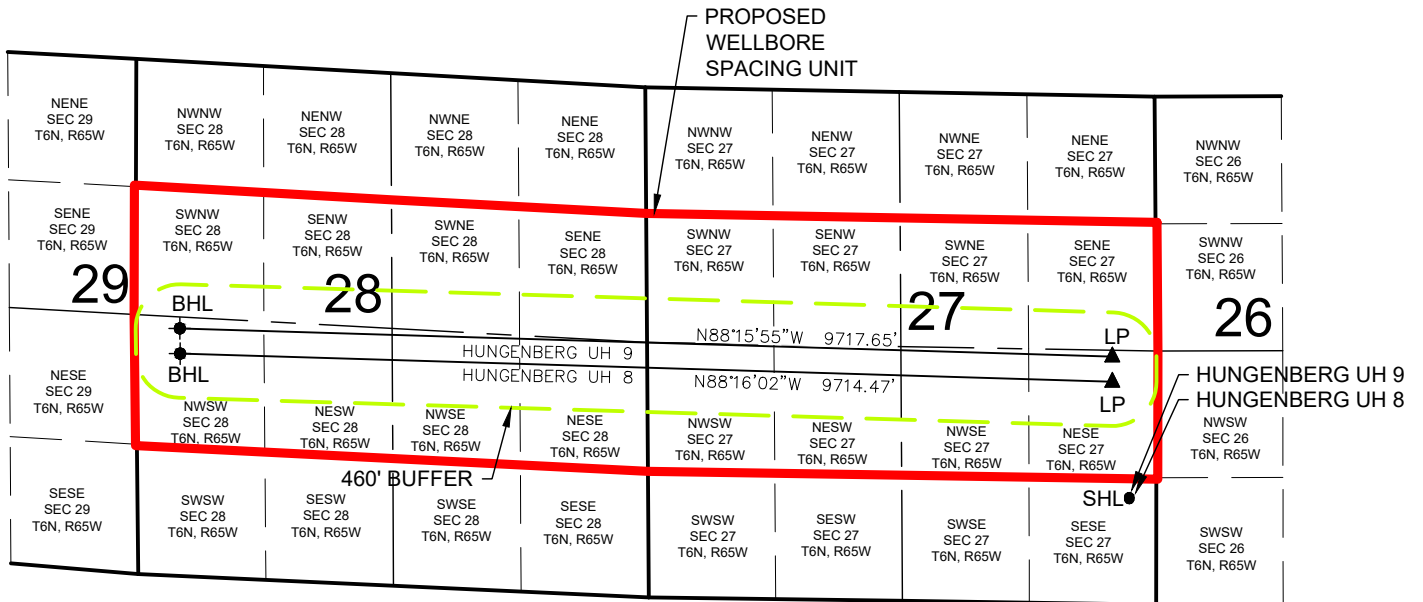

SEC 27 & 28: N2S2



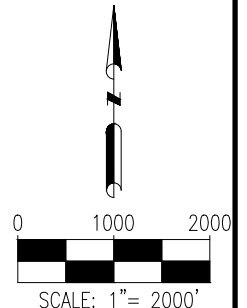
**HUNGENBERG UH 8 WELL TO BE LOCATED 1096' FSL AND 282' FEL, SEC 27, T6N, R65W**
