Comment Per Rule 1003, all disturbed areas affected by drilling or subsequent operations shall be reclaimed.

Vehicle rutting disturbance from a workover rig was observed up to ~150 feet away from the wellhead. Refer to the attached inspection photos.

Corrective Action Comply with Rule 1003 to repair all rutting and reseed no later than 5/6/2020 using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1003 standards, including weed management.

Comment: Pursuant to Rule 1002.f.(2)F, Operators shall implement vehicle tracking control practices to control potential sediment discharges from operational roads, well pads, and other unpaved surfaces.

The vehicle tracking device BMP was not sufficient to properly function due to the wet conditions during the recent work. Also, the culvert was damaged due to vehicle traffic.

Corrective Action: Operator shall maintain vehicle tracking BMPs on the oil and gas location to comply with rule 1002.f.(2)F and repair the culvert. Operator shall ensure material tracked onto Lansing Ct. is cleaned up.
