COMMENTS:

TEP Rocky Mountain LLC (TEP) requests approval to tie the PA 13-35 well's bradenhead into the sales line. A facility diagram for plumbing the bradenhead into the sales line is attached along with a graph showing the past 6 months of line pressure. Based on the surface casing setting depth of 1721' and fluid level assumed at surface, the threshold pressure at surface is 436 psi in order to stay below a 0.683 psi/ft gradient at the shoe. Tying to the sales line will allow the bradenhead pressure to equalize with our sales line pressure which is currently at 120 psi (4/15/2020 see attached graph for trend), and protect the integrity of the surface shoe by preventing a pressure build up above 436 psi. This well is manifolded to a 2" pipe with check valve at the wellhead to prevent backflow and for bradenhead isolation.

A bradenhead test was conducted on 1/24/2020, Form 17 Doc #402291978 was submitted. The bradenhead was vented 1 time for 24 hours in 2019.
