Approximately 200 musk thistles observed within the western portion of the interim reclamation area. Revegetation is progressing within portions of the interim reclamation area, although re-seeding may be needed in the western project area after weed infestation is controlled.

Corrective Action

Control weeds at the appropriate time, before flowering, and no later than 6/1/2020. This is the second corrective action to control weeds at this location. Additional treatments will likely be needed in 2020 to control infestation.
