While there, I observed a shut in wellhead. During this inspection the following possible compliance issues were observed: 1. Appears to be stained soil at 3 wellheads (underneath master valve). CONDUCT MAINTENANCE ON EQUIPMENT, CLEANUP STAINED MATERIAL AND REVIEW SELF INSPECTION PROCESSES PER RULE 1002.F.(2).D. (Corrective Action Date: April 20, 2020) See attached photos #3, 6, 9. 2.
