#### COMMENTS:

On 8/25/2019 a CIBP with 4 sx of cmt was set @ 7830' over the JSand and on 8/26/19 a CIBP with 4 sx of cmt was set @ 7170' over the NB-CD with a 5K wellhead closing well to the atmosphere. This well is partially plugged and we are waiting until summer of 2020 to determine if gas migration goes away until we complete the P&A. The MIT was reported via form 21 doc #402239921.
