The former GURTLE 24-10J well (API: 05-123-15152) was P&A'd on January 6, 2015 as identified in the Form 6, Document Number 400769144. On August 26, 2019, LTE conducted a final reclamation inspection for the former GURTLE 24-10J well pad (Location ID: 327788). All disturbed areas have been compacted and stabilized. The reclaimed well pad and tank battery location are now located within the Wattenberg 101 Loadout Facility and Oil Stabilization Facility grounds. The associated tank battery has been removed and is located 0.14 miles south. LTE personnel located the P&A wellhead location using a handheld Trimble (R1) Global Positioning System (GPS) unit and latitude and longitude coordinates obtained from the COGCC online database. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location. Please see the attached letter, general site location map and photographic log.
