The DACONO STATE 6-36 is a plug and abandonment in process. CIBP set at 7440' with 25 sacks cement. CIBP and casing were pressure tested to 1000 psi for 15 minutes on 10/25/2019. Pressure test information submitted with Ops Summary attached. TA status provided via down-hole plug and surface isolation provided by closed master valve. Plug and Abandonment is estimated to be completed by end of 2021.
