The well location entrance was locked with livestock. COGCC staff will have to perform a future inspection to ensure all equipment was removed and the well location meets vegetative standards. Refer to the attached inspection photos.

Operator has performed final reclamation activities with the evidence of drill rows and straw crimped mulch for the associated offsite tank battery. The access road had sparse germination of desirable species compared to the tank battery.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards.
