 Activities were suspended on 01/28/2020, prior to reaching TD to optimize production of adjacent wells. Great Western anticipates recommencing drilling in Q3 of 2021 with a large rig and plans to set production casing prior to completing the well in Q4 of 2021

The TPZ and BHL footages are taken from the APD.

The depths are from the smaller surface rig and will change based on the production rig's KB on the final reports.
