While there, I observed a Temporarily Abandoned location.
During this inspection the following possible compliance issues were observed:
Tubing stored at wellhead. See photo 3. Comply with Rule 603.f by 7/24/2020.
Dried annual weeds on location. See photos. Comply with Rule 603.f by 5/11/2020.
Stained soil at wellhead. See photo 2. Comply with Rule 603.f, securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition per Rule 605.d, and properly dispose of oily waste in accordance with 907.e by 5/8/2020.
