	<p>This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 6/12/2018. Operator has failed to complete final reclamation at the well location and a portion of the well location access road. There is no evidence to suggest final reclamation activities were completed. Annual, weedy vegetation with bare ground was observed at the well location and access road. Reference area vegetation is mostly comprised of crested wheatgrass.</p>	
Corrective Action:	<p>Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p>Corrective action date is being back dated to when all final reclamation activities should have been completed.</p>	Date <b>06/12/2019</b>
