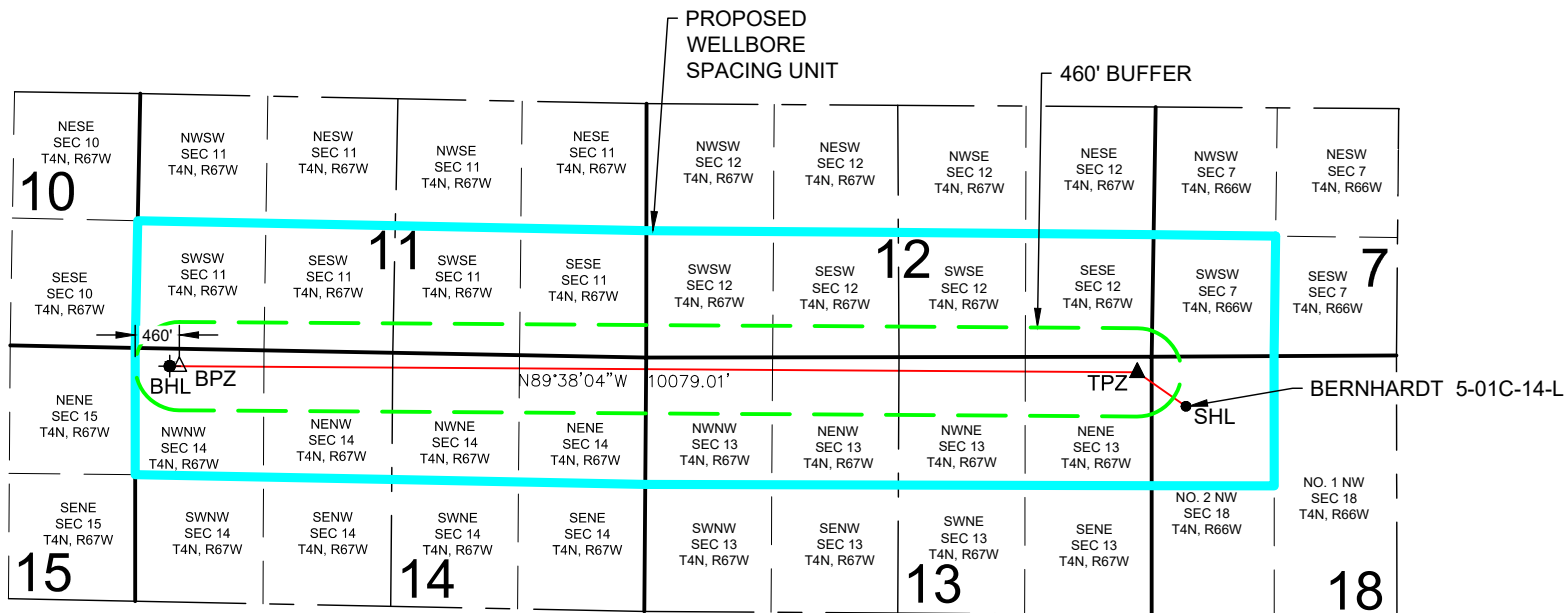

BERNHARDT 5-01C-14-L WELLBORE SPACING UNIT

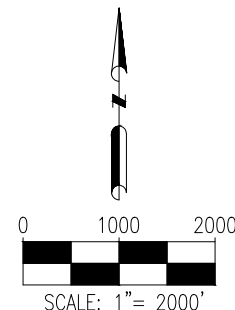


BERNHARDT 5-01C-14-L WELL TO BE LOCATED 518' FNL AND 357' FWL, SEC 18, T4N, R66W
