## OPERATOR COMMENTS AND SUBMITTAL

Comments

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 383' FNL & 460' FWL, Section 14. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

The distance to the completed portion of the nearest well on the "Spacing and Formations" tab was measured to the Bernhardt 13A (05-123-19805). The distance to the nearest wellbore belonging to another operator on the "Drilling & Waste Plans" tab was measured to the Ehrlich 13-22 (05-123-19846). Both distances were measured via the anti-collision report.

PDC Energy is the successor in interest to SRC Energy, Inc. The subject location was one of several locations that PDC Energy inherited from SRC Energy, Inc, effective 1/14/2020. Some attachments for this location may still reference SRC Energy, Inc.

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall state "Alternative Logging Program - No open-hole logs were run" and shall clearly identify the type of log and the well (by API #) in which open-hole logs were run.
