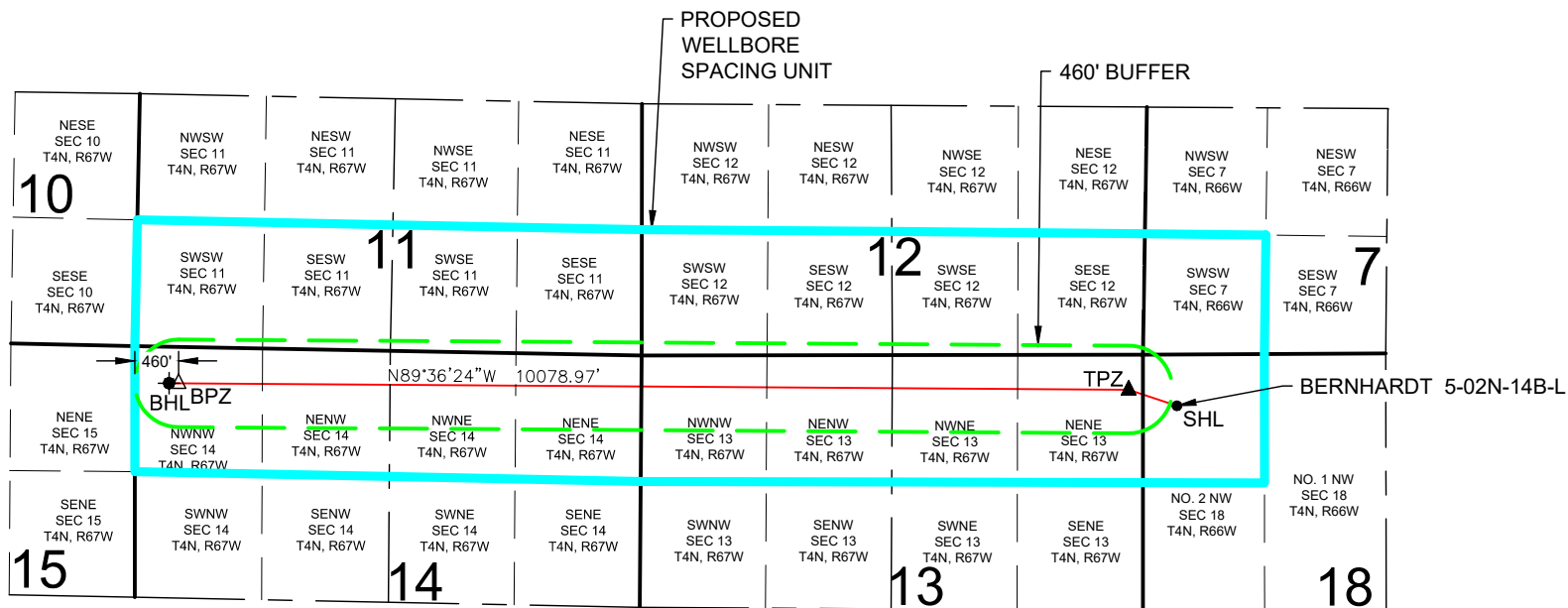

# BERNHARDT 5-02N-14B-L WELLBORE SPACING UNIT

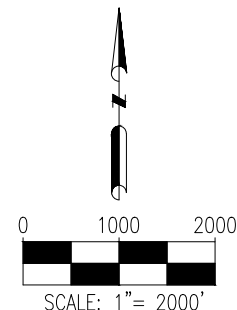


BERNHARDT 5-02N-14B-L WELL TO BE LOCATED 538' FNL AND 357' FWL, SEC 18, T4N, R66W
