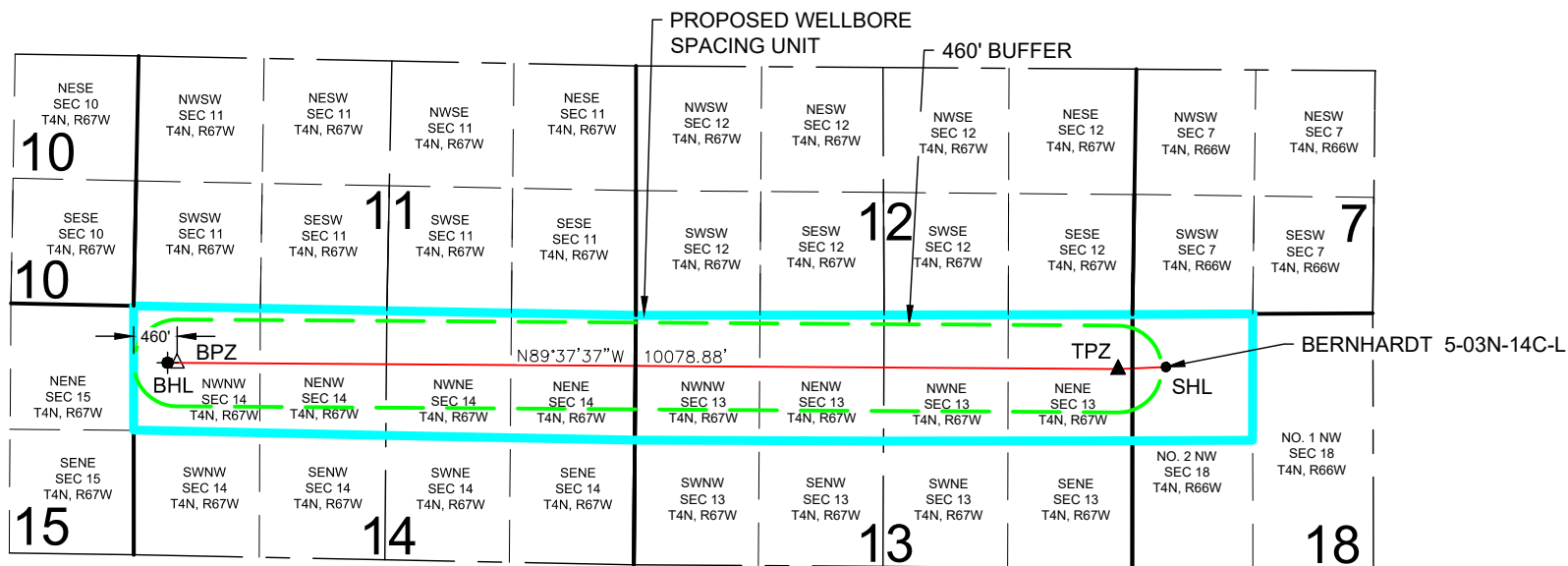

BERNHARDT 5-03N-14C-L WELLBORE SPACING UNIT

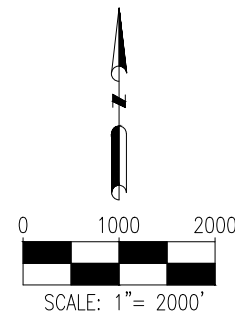


BERNHARDT 5-03N-14C-L WELL TO BE LOCATED 558' FNL AND 357' FWL, SEC 18, T4N, R66W
