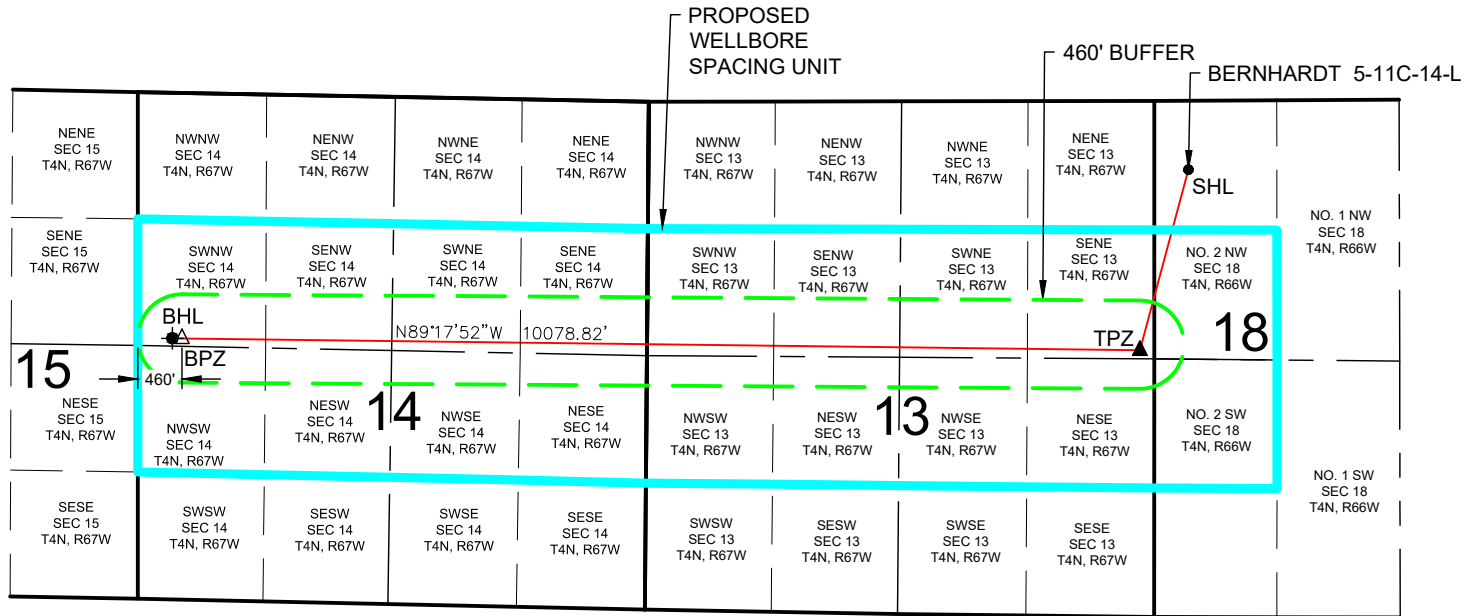

# BERNHARDT 5-11C-14-L WELLBORE SPACING UNIT

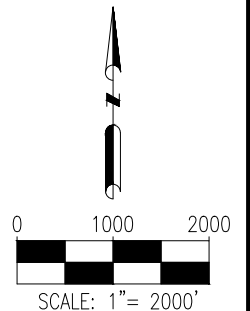


BERNHARDT 5-11C-14-L WELL TO BE LOCATED 718' FNL AND 355' FWL, SEC 18, T4N, R66W
