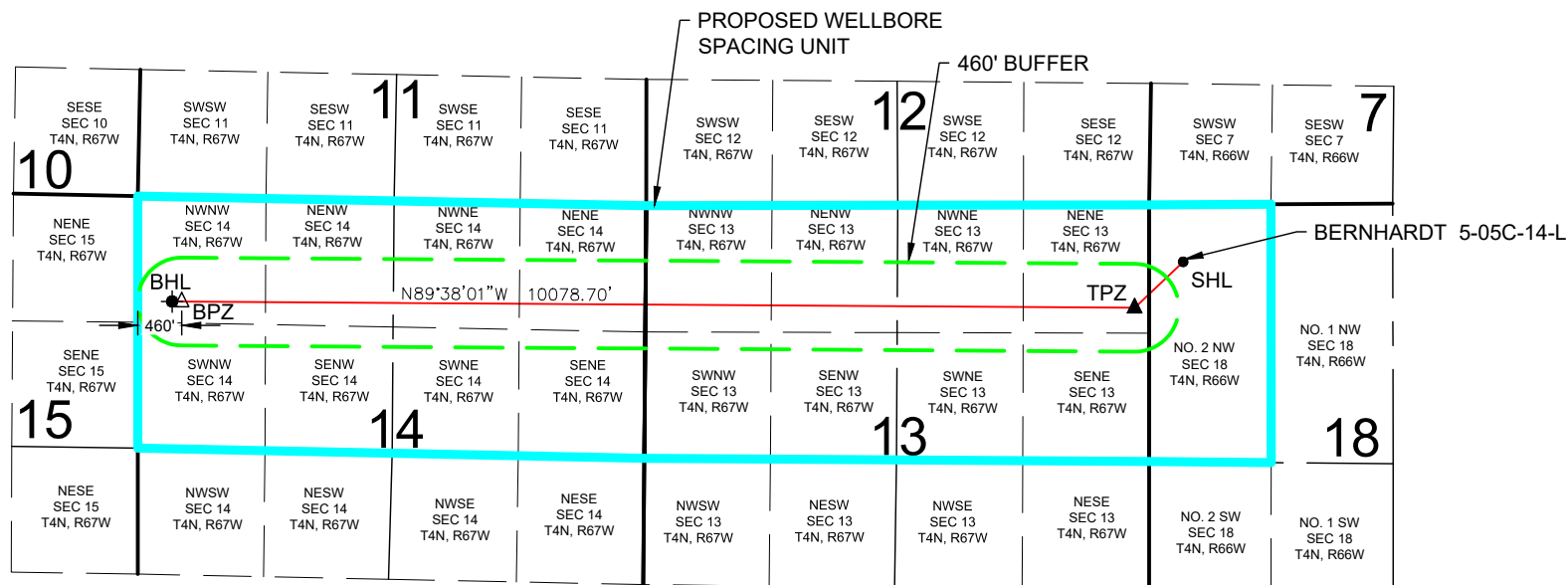

BERNHARDT 5-05C-14-L WELLBORE SPACING UNIT

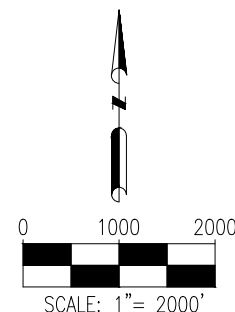


BERNHARDT 5-05C-14-L WELL TO BE LOCATED 598' FNL AND 356' FWL, SEC 18, T4N, R66W
