PDC Energy is the successor in interest to SRC Energy, Inc. The subject location was one of several locations that PDC Energy inherited from SRC Energy, Inc, effective 1/14/2020. Some attachments for this location may still reference SRC Energy, Inc.

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 1343' FNL & 460' FWL, Section 14. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

The subject well will have a treated interval less than 150' from the treated interval of the Bernhardt 13-12 (05-123-17357) owned by Noble. Please see the Rule 317.s Stimulation Setback Consent attached.

The distance to the completed portion of the nearest well on the "Spacing and Formations" tab was measured to the Bernhardt 13-12 (05-123-17357).
